"Combining our locally developed Intellectual Property (IP) with the backing of a global energy management solutions leader, means we can progress towards mass EV adoption without overloading the wider electricity grid. This problem is not unique to New Zealand, but as an island nation with an abundance of renewable energy, we are well placed to lead the world in electrification which Landis+Gyr has recognised."

Thundergrid's commercial independence including current management and team structure will be retained to drive the company's vision and strategy in New Zealand.
